

The Piggy Pen

UNDERSTANDINGS AND AGREEMENTS

I agree and understand that for pets staying less than 30 days at The Piggy Pen, a deposit of half the expected boarding costs is due at the time of pick up, if I requested transportation, or upon arrival at The Piggy Pen. If my pet is staying more than 30 days at The Piggy Pen, the first month's board is due upon pick up, if I requested transportation, or upon arrival at The Piggy Pen.

I agree to make complete and final payment to The Piggy Pen for all services rendered to my pet at the time of pick up or upon the return of my pet, if paying for pet transport. If my pet is staying for over 30 days at The Piggy Pen, I agree to pay each month's board on the first of each subsequent month after my pet arrives at The Piggy Pen.

If my pet is staying less than 30 days at The Piggy Pen, I understand and agree that if I fail to pick up or complete the return transport of my pet within twelve (12) days of the scheduled pick up or return date, then The Piggy Pen may consider my pet to be abandoned and handle its final disposition in whatever manner The Piggy Pen deems appropriate, consistent with the law (Sections 1834.5 and 1834.6 of the Civil Code). I understand that abandoning a pet does not relieve me of my financial obligations and I will also be responsible for all costs associated with my pet's extended stay at The Piggy Pen until final disposition is complete.

If my pet is staying more than 30 days at The Piggy Pen, I understand and agree that each month's boarding fee is due on the first of the month. I understand and agree that if I fail to pay my monthly boarding fee by the 10th day of the month, The Piggy Pen will notify me via certified mail at the last known address that my pet will be considered abandoned if I do not pay the past due boarding fee within 10 days of receipt of the certified letter. I understand and agree that if I fail to pay the past due boarding fee before the month's end, The Piggy Pen may consider my pet to be abandoned and handle its final disposition in whatever manner The Piggy Pen deems appropriate, consistent with the law (Sections 1834.5 and 1834.6 of the Civil Code). I understand that abandoning a pet does not relieve me of my financial obligations and I will also be responsible for all costs associated with my pet's extended stay at The Piggy Pen until final disposition is complete.

Transportation and Boarding Risks: I understand that certain animal health conditions are unpredictable or unavoidable during crating, transporting and in boarding environments, including, but not limited to, the following: over-exertion, fatigue, reduced sleep, anxiety, stress and stress related illnesses, weight loss, upper respiratory infection, bronchitis, diarrhea, rough hair coat, hair loss, cuts and lacerations, tooth injury, and escape. Therefore, I request that The Piggy Pen take all reasonable steps to prevent the development of such problems in my pet while he or she is being crated, transported and/or boarded. However, recognizing that it is not possible to avoid all risk, I agree that I will not hold The Piggy Pen and its Owner/Operator responsible for any such problems or illnesses, which may arise out of my pet's stay or transportation to and from The Piggy Pen.

Emergency/Illness: Should the pet(s) identified on this record become ill or experience an accident, injury, or emergency, I request that The Piggy Pen seek medical and/or surgical treatment it deems necessary and I agree to pay for any such emergency treatment.

I acknowledge that in the event of my pet's illness, the staff at The Piggy Pen may not be able to contact me immediately and is therefore authorized to initiate appropriate treatment until I (or the pet's agent) can be reached. I agree to pay all related expenses associated with the treatment of my pet until I am available to discuss further care and fees with the attending veterinarian.

I certify that I have read the above and foregoing Boarding Admission Agreement and that I understand the contents and meaning of this document. I certify that I am over 18 years of age and I am the owner of the above described pet, or the owner's legal representative, or that I am duly authorized by the owner to act as his/her general agent to execute this document and accept its terms.
